The Jermyn Borough Council met on Thursday, May 15, 2025, at 7:00 p.m. in the Council Chambers of the Jermyn Borough Building, 440 Jefferson Ave, Jermyn, PA 18433.

The meeting was called to order by President Frank Kulick with the Pledge of Allegiance.

Correspondence: F. Kulick read a letter received from Mary Liz Desanto in regards to the Act 167 county-wide stormwater management plan agreement. K. Napoli accepted to serve as the representative to serve on the watershed advisory committee.

Public Comment: Tom Terpak from the 400 block of Madison Ave. has come in concerned about the property next door to his. He has voiced his issues to the council and the mayor, but was told we needed to appoint a code enforcement officer to take care of the property maintenance issues. The council advised that they will take action on the issue.

Next was Mark Cordelli from Lackawanna County, who wanted to update the council on the upcoming events within the county and provided flyers to be posted at the borough.

Last was Stacy Cook, who wanted to introduce herself to the council and advise them that she plans on running for the open Mayor position at the upcoming elections on Tuesday.

Rushbrook Creek project update: F. Kulick went over in more detail what was discussed at the meeting. It sounds like everything should be in place by the fall, so the project should be able to be put out for bid and start next spring.

<u>Code Enforcement:</u> F. Kulick would like to re-advertise for this position to see if we could pull some more interest in the open position.

New business: A. Fuga wanted to seek some direction, being Memorial Day will be coming up, in regards to the hometown hero banners and if they were going to be put up again. When the program originated, the banners were to be placed up for three years, then returned to the families that purchased them. We are coming up on year five, and some are starting to show some severe signs of wear, so we would like to know if they should be placed out again this year. F. Kulick said he would reach out to Shade Tree to see what should be done, and when the flags will be given back to the families.

A. Fuga advised that Shade Tree had gotten a quote for the trees out front of the borough building to be trimmed, the quote came back at \$150.00 per tree, which will total \$1650.00. Council decided to table this at this time, till they get more information.

Adjournment: A motion was made to adjourn by J. Morcom. Seconded by K. Napoli. All members in favor. The meeting adjourned at 8:00 pm.
