Recreations: S. Lee advised council that she was looking into purchasing wall mounted fans for the gym area, that would be motion censored along with an on off switch. As the fans that are located in the gym tend to be left on by renters raising the electric bill and also, they are larger floor fans that could be possibly dangerous if anyone where to stick anything in them while running. She presented council with a possible option. C. Tomaine also offered in reaching out to someone he knows to see if their may be any better pricing for something with the same features.

It upgrades info: S. Lee advised that the police department will need to have some technology security systems in place before the end of this year in order for them to be able to access certain legal systems required to do their jobs. After speaking with our current IT company, I do not feel they will be able to meet this need of requirement, as they were unsure of what I was speaking of when I called to see if they where aware of the new regulations coming out for police departments. The police chief and her have meet with another company, that is servicing all the other neighboring towns/boroughs, they where able to give a rough quote as to what the services would cost. At this time, she had given each council member a copy of the quotes and asked them to look it over as it was going to be quite a bit more than our current cost, and we will need to budget for this accordingly if we decide to go forward with this company.

At this time council made a request to see if they would be able to attend our next council meeting to address any questions, they end up having after review.

Paving project advertisement: A motion was made to advertise the Jermyn Boroughs 2025 paving project, for bid opening to be held at the March council meeting by J. Morcom. Seconded by C. Tomaine. All members in favor. Motion carried.

Rushbrook creek project: Brendan advises that they have filed with the courts for eminent domain on the properties that have not been responsive to obtain possession.

New business: S. Lee advised that she has gotten a request from a new resident to have an Autistic child sign placed out front of their home, as the son is none verbal autistic child. Brendan will be able to have a resolution for the next council meeting for the placement of the signs, but would like approval to move forward with purchasing the two signs that will be needed.

A motion was made to purchase two autistic child signs that will be placed on the 300 block of Lackawanna St. by J. Morcom. Seconded by C. Cook. All members in favor. Motion carried.

B. Davis wanted to let the borough know that the community bank is now offering to municipalities a free credit card service for the tax collectors to use. So that residents would be able to pay their taxes with a card if they choose and that there would be a credit card fee charged to them and not the borough.
