**RESOLUTION 15 - 2016**

**A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF JERMYN,  
LACKAWANNA COUNTY, PENNSYLVANIA,**

**WHEREAS**, On August 13, 1992, the Borough of Jermyn enacted an Ordinance 2 of 1992 titled Jermyn Borough Ordinance Governing the Requirements for the Use of Private and/or Roll-Offs on Paved Roadways within the Borough of Jermyn (the "Ordinance"); and

**WHEREAS**, Council desires to amend Section 2 and Section 3 of Ordinance 2 of 1992.  
**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Borough of Jermyn, Lackawanna County, Pennsylvania as follows:

Section 1. In accordance with § 3301.1 of the Borough Code, Council amends Section 2 of Ordinance 2 of 1992 to read as follows:

"There is imposed a fifty-dollar (\$50.00) fee for obtaining a permit for the use of a private dumpster or roll-off on any borough paved roadway."

Section 2. In accordance with § 3301.1 of the Borough Code, Council amends Section 3 of Ordinance 2 of 1992 to read as follows:

"Prior to obtaining a permit for the use of a private dumpster or roll-off on a borough paved roadway, an applicant must post a bond in the amount of one thousand dollars (\$1,000.00) which bond will be used to remedy any damage to borough paved roadways which may arise out of the use of the private dumpster or roll-off."


Section 3. The proposed amendments to Ordinance 2 of 1992 shall be published in accordance with § 3301.2 of the Borough Code and shall be available to be examined at the Jermyn Borough Building in accordance with § 3301.2 of the Borough Code.

Section 4. In the event, any provision, section, sentence, clause, or part of this Resolution shall be held to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, such invalidity, illegality, or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses, or parts of this Resolution, it being the intent of Council that the remainder of the Resolution shall be and shall remain in full force and effect.


Section 5. This Resolution shall be effective immediately upon Council's vote at the December 1, 2016 meeting.
