**RESOLUTION 13 - 2016**

**A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF JERMYN,  
LACKAWANNA COUNTY, PENNSYLVANIA,**

**WHEREAS**, On March 12, 1998, the Borough of Jermyn enacted Ordinance 3 of 1998, titled An Ordinance Regulating Canvassing and Soliciting Within the Borough of Jermyn, Providing and Establishing Registration and Fees; Providing for Certain Stated Exceptions from Such Regulations; and Fixing Penalties for Violations thereof; and

**WHEREAS**, Council desires to amend Section X and Section XI of Ordinance 3 of 1998.  
**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Borough of Jermyn, Lackawanna County, Pennsylvania as follows:

Section 1. In accordance with § 3301.1 of the Borough Code, Council amends Section X of Ordinance 3 of 1998 to read as follows:

“Every person engaged in canvassing and soliciting in the Borough, and not exempted from the requirements of this ordinance, shall pay a registration of one hundred dollars (\$100.00) per person and twenty-five dollars (\$25.00) for each motor vehicle registered to be used in canvassing and soliciting.”

Section 2. In accordance with § 3301.1 of the Borough Code, Council amends Section XI of Ordinance 3 of 1998 to read as follows:

“That any person, firm or corporation or other group or entity violating any of the provisions of this ordinance, upon conviction thereof before the Mayor of the Borough of Jermyn or before any District Justice, shall be fined a sum of five hundred dollars (\$500.00) for the first offense plus costs of prosecution, and in default of payment of same, shall be sentenced to imprisonment in the Lackawanna County Prison for a period of not more than thirty (30) days or until such fine and costs shall be paid. The penalty for second and subsequent violations of this ordinance will result in a fine in the amount of one thousand dollars (\$1,000.00) and imprisonment in the Lackawanna County Prison for a period of thirty (30) days.

Section 3. The proposed amendments to Ordinance 3 of 1998 shall be published in accordance with § 3301.2 of the Borough Code and shall be available to be examined at the Jermyn Borough Building in accordance with § 3301.2 of the Borough Code.

Section 4. In the event, any provision, section, sentence, clause, or part of this Resolution shall be held to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, such invalidity, illegality, or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses, or parts of this Resolution, it being the intent of Council that the remainder of the Resolution shall be and shall remain in full force and effect.


Section 5. This Resolution shall be effective immediately upon Council's vote at the December 1, 2016 meeting.
